Where We Stand: Executive Director's Corner

2018-19 has been another year of highs and lows in Pennsylvania. We passed the first real piece of gun reform legislation in years, the

bill to disarm domestic abusers, and saw a broad bipartisan coalition come together to do it. But our gun deaths and shootings have increased, and Squirrel Hill was the site of the deadliest hate crime against Jews in this country. We elected more officials who pledged to make gun violence prevention a priority but still our legislature lets good bills languish in committee with no action or even discussion.

There is so much work to do. The good news is, there are more of us engaged in the fight. And we have new tools like our Texting program to make advocacy even easier. We are creating advocacy toolkits, video libraries and action taker resources so you can help us engage even more folks in this critical work.

We know it can be discouraging to have ongoing and repeated tragedies met with

silence by our policymakers. Our task is to make that silence unacceptable. We are a growing force that will not be ignored. To continue that growth, this year we have hired an organizer based in Scranton, and our staff travels across PA to engage in dialogue and educational work. We know these efforts are paying dividends — our action rates are increasing and we have local folks writing and calling every Representative and Senator in the Commonwealth.

The challenge is to keep energy and engagement high in the face of the frustratingly slow pace of policy change. Your support — on the ground, as ambassadors for the work and as donors — helps us do that. Thank you for all you do.

Standing Up

The close of the 2017-2018 legislative session brought victory in the form of Act 79, the bill to disarm domestic abusers. This was a significant accomplishment that will make Pennsylvania families safer. And, it helped create a foundation for gaining bipartisan support for commonsense policies. We are hoping to build on this foundation to enact strong policies like Extreme Risk Protection Orders in the 2019-2020 session.

We have been testifying in policy hearings and bringing groups of activistsincluding survivors, medical providers and students- to lobby at the Capitol. We are supporting HB 1075 and SB 90, the ERPO bills. We are seeking support in the Judiciary Committees, which are under new leadership, and we have been holding educational meetings with stakeholders including medical providers, veterans and suicide prevention advocates. We believe PA can and should pass this measure and join the growing number of states (15 at the time of this writing) that are giving this tool to concerned families and law enforcement.

We are again fighting against punitive preemption, also known as the Sue Our Cities Bill. Our advocacy over the last few legislative sessions has created an educated force of Pennsylvanians who understand the dangers of this legislation.

This latest attempt follows Pittsburgh's litigation in Schuylkill County. efforts to enact local ordinances to keep the community safe. In days, we had more than one thousand emails and hundreds of calls placed to key Senators, and we were able to temporarily get this bill moved off the calendar. We plan to continue our advocacy and will do all we can to continue the streak of keeping this bill off the Governor's desk.

As always, we are fighting efforts to weaken our existing laws and advance the gun lobby's guns for everyone everywhere agenda. This includes a bill to allow anyone to carry concealed without a license, a dangerous proposal opposed by law enforcement, and an effort to arm teachers. We are fighting the guns in school movement in the legislature and in

On the federal level, we applauded the passage of HR 8 and HR 1112 to strengthen the federal background check system. Our goal now is to advance these bills in the Senate, where we have the support of Senator Casey but need to advocate for Senator Toomey's support.

The summer gives us several months when legislators are in their district offices, away from Harrisburg. This is a great time to go visit your Representative and Senator and let them know what you're concerned about and what you expect them to do. Let us know if we can help set up a meeting or get you and a group prepared for a discussion with your

TAKING A STAND

SPOTLIGHT: DOCTORS

This year we kicked off a new program directed at medical students and doctors. We wanted to build on the conversations we were having with medical providers and students and create a focused advocacy training program. Medical providers can be advocates in the patient-care room and in the community, and they are trusted, credible messengers. Materials were created to guide the doctorpatient firearm discussion beyond questioning if there is a firearm in the home to a discussion about the risks of guns in the home, safe storage, and responsible ownership. We also wanted to offer these leaders guidance for using their voices in the broader community, in the media and with policy makers. We urged them to "Put on the White Coat and Speak Up!" We have had great success with the program and held 18 sessions throughout the

year with different members of the medical community. The NRA's November 2018 warning to doctors to "stay in their lane" intensified interest by medical providers in working with us. We have created a partnership with a coalition of trauma surgeons who are engaging their colleagues -- doctors, nurses and first responders -- across Pennsylvania. We are working with them to develop strategies to move beyond ThisIsOurLane#.

In addition to our training programs, we held our first Harrisburg advocacy day with the medical community in January 2019 where we brought supporters, partners, and medical providers from across the Commonwealth to speak with legislators about policies that can help reduce gun violence, like Extreme Risk Protection Orders and fighting gun trafficking. We are currently planning our next trip to the Capitol for health care providers; if you are interested in lending your voice, please join us!

SPOTLIGHT: YOUTH

This past year we have seen an explosion in gun violence prevention activity by young people. The March for our Lives movement sparked an interest in speaking out and advocacy, and we have been fortunate to partner with students of all ages. We held over 30 leadership institutes this past year with schools and youth groups across the Commonwealth. We discussed Pennsylvania firearms policy, often through the context of local current events such as the shooting at the Tree of Life Synagogue in Pittsburgh and the decision by a Tamaqua school board to arm their teachers. We coordinated many of these sessions with students to coincide with bus trips to the Capitol to hold press conferences and speak with legislators.

We were fortunate to receive another grant this past year from the Pittsburgh Foundation, William K. Fitch Fund, for the Motivating Young Citizens Project. The grant provided for CeaseFirePA to conduct advocacy education and training programming in several high schools and after school programs in Pittsburgh. We were able to weave lessons and discussions about PA legislation and firearms policy with current events like the tragedy at the Tree

of Life Synagogue and the death of Antwan Rose for a very relevant and impactful curriculum. The year culminated with a trip to the Capitol for a press conference and talks with state legislators.

The young adults we have had the opportunity to work with are engaged and eager to build their knowledge base to take the lead on gun violence prevention measures. We look forward to reaching more students and supporting their activism in the coming year.

KEYSTONE COURAGE AWARD

On April 7, 2019 CeaseFirePA honored Fred Guttenberg with the Keystone Courage Award. Fred has been a tireless advocate for gun violence prevention since the loss of his daughter Jaime at the tragic shooting at Marjorie Stoneman Douglas High School in Parkland Florida on February 14, 2019. Fred has inspired us with his ability to turn enormous grief into action, aggressively pursuing strategies to enhance public safety, enact common

sense gun safety and turn out the vote through his non profit dedicated to Jaime's life called "Orange Ribbons for Jaime." At the event, Fred inspired the crowd to further action, and shared that we gave him hope that change was coming.

CeaseFirePA also presented the Lighting the Way Forward Awards to Dr. Amy Goldberg, and Scott Charles, MAPP. Dr. Goldberg is Professor and Chair of the Department of Surgery at the Lewis Katz School of Medicine, Surgeon-in-Chief of Temple University Health System. Mr. Charles is the Trauma Outreach Coordinator for Temple University Hospital and is the Director of TUH's Cradle to Grave Program, a hospital based violence prevention initiative. Through their work with trauma informed care, both Dr. Goldberg and Mr. Charles have been leaders in the movement to view gun violence prevention as a public health initiative. They are saving lives through their work in the Hospital and out in the community.

A crowd of 300 assembled to honor these heroes and commit to ongoing action to reduce gun violence. Thank you for being part of this special night. Next year, we hope you will join us when we present the Keystone Courage Award to Senator Bob Casey.

We measure success in so many ways: passing the new law to disarm domestic abusers, blocking bad policies like the Sue Our Cities bills, a full Rotunda Rally even on a snowy day, and growth in the numbers of people attending programs and taking action. This year, we have some exciting accomplishments to share -- accomplishments that you made possible by your advocacy, action taking and support!



Voter Turnout Significantly Increased in Key Districts

We targeted 50,000 voters in key districts who generally skip midterm election with a mail piece highlighting that gun violence prevention is always on the ballot. 56% of those voters showed up and voted in November 2018!

1,009 new voters registered in Pennsylvania


CEASEFIRE PENNSYLVANIA 501 C4 INCOME




CEASEFIRE PENNSYLVANIA 501 C4 EXPENSES
