Already responsible for winning \$65 million in funding for community-based violence intervention programs, we are looking for a dynamic coalition builder and strategist to coordinate our efforts statewide as we work to win dedicated, long-term funding for programs that reduce violence through intervention and prevention.

Cities throughout the country have proven that targeted programs that use the wisdom and connections of the community can reduce violence quickly by interrupting cycles of violence and helping people heal. Funding community-led efforts to interrupt cycles of violence can cut shootings up to 50 percent. It's time for Pennsylvania to invest.


The Commonwealth invested \$65 million in these programs in 2022, but that's dwarfed by the size of this crisis that costs PA \$12 billion each year. It's why we're calling for a multi-year investment in these strategies so they have the resources to work.



ROLE AND RESPONSIBILITIES

The Campaign Manager will lead our efforts in Philadelphia with half their time spent coordinating our statewide strategy to pass long-term guaranteed funding while supporting efforts in other cities.

- Lead our Invest In Safer Communities Campaign by working with Executive Director and other staff to develop a coordinated statewide strategy to increase funding and crafting effective tactics;
- Build and manage coalitions of community violence intervention organizations to highlight local successes in these efforts, understand their needs, and engage in advocacy;
- **Craft compelling messaging materials** including reports, briefs, and factsheets that connect key solutions to the experience of gun violence across the Commonwealth;





• **Persuasively speak about the need for additional resources** at community forums, town halls, and with decision-makers;

QUALIFICATIONS

- 5+ years experience in developing campaigns, coordinating coalitions or directly working in community violence intervention efforts;
- Strong preference for lived experience with community violence or intervention programs;
- Proven success in building diverse coalitions with competing interests, including navigating complex situations to come to a common approach;
- Highly organized individual able to drive multiple projects simultaneously while maintaining quality;
- Strong written and verbal skills able to connect community violence intervention programs with public investment needs;
- Oriented towards hitting qualitative and quantitative goals by developing concrete plans that build on each other, with the ability to evaluate efforts afterward;
- Relevant work experience is required to apply for this role. A college degree may be helpful but is not required.
